Course Description:

The presentation will give an overview of how the current state of genetics ten years after the completion of the Human Genome Project is affecting forensics, genealogy and health care.

Speaker Bio:

Jim Hartsfield, DMD, PhD, is the E. Preston Hicks Endowed Chair and Professor of Orthodontics and Oral Health Research at the University of Kentucky College of Dentistry, and Professor of Microbiology, Immunology and Molecular Biology at the UK College of Medicine. Jim received his DMD from the Medical University of South Carolina, his MS in genetics from Indiana University, a MMSc in Oral Biology and certificate from the Harvard School of Dental Medicine, and a PhD in medical sciences from the University of South Florida College of Medicine. He also completed two years of genetics residency at the Indiana University School of Medicine and the University of South Florida College of Medicine. As a board certified orthodontist and a board certified clinical geneticist, Jim has been involved with patient care and research in both areas, and has a particular interest where genetics and health care overlap.
